- Applied and received \$5000 Community Initiatives Fund (CIF) Grant for sponsorship which was returned due to cancelled camper season.
- As we all will remember for many years to come, the province of SK went into a state of emergency lockdown on March 20 due to the growing international COVID-19 pandemic. This situation was ever-evolving and lasted for the remainder of the year and into 2021.
- The Board initially suspended hiring & programming plans throughout the spring, eventually cancelling the 2020 camper season in June due to the continuing provincial government state of emergency restrictions. All camper registrations were refunded.

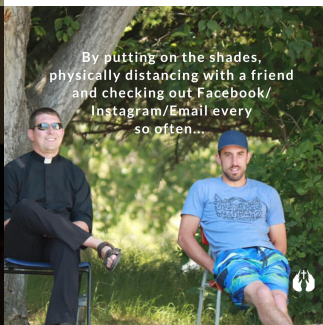

- Grateful for all those that financially donated during our pandemic season keeping us operating to minister in future seasons.

Challenges:

- 70th Anniversary discussions tabled during COVID-19 pandemic season.
- Applied but did not receive any Canada Summer Jobs Grant Program funding.
- All potential rentals (excluding 2 hr wedding rental) were cancelled this season (Swift Current Girl Guides, Living Hope Church, Carleton Reunion).
- We continue to call for active volunteers with working hands and servant hearts...both Board members & on-site volunteers.
